Vehicle Registration Terms and Condition

Name _____

The exhibitor hereby applies to the producers of the Northwest Rodarama Rod and Custom to have the vehicle described displayed and agrees that, if the application is accepted, he will display the vehicle at the show under the following terms and conditions:

- A. The producer shall have the final authority to determine the location of an exhibitor's display within the show.
- B. Once the exhibitor's display and/or vehicle are set up in the show, they shall not be moved, removed or concealed by the exhibitor prior to the end of the show without the permission of the producers.
- C. No commercial advertising is allowed with entries unless they are appearing in conjunction with paid commercial space. A single sign may be used to identify major modifications, identifying who did them, and what equipment was used, but large ad signs, handbills or business card distribution is prohibited. In consideration of this entry, the owner and spouse and guests agree to permit the Northwest Rodarama or its assigns the use of their names and pictures of the entered vehicle for publicity, advertising and commercial purposes (including newspapers, magazines, radio, television and Internet) before, during and after the event and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and hereby give permission to publish or sell or otherwise dispose of said photographs to Northwest Rodarama.

Exhibit space Information:

Standard display spaces are 10' x 20' for cars/trucks and 10' x 10' for motorcycles. Larger spaces are available for FULL displays and must be approved by the Show Producers prior to entry deadline (3/1/18). Exhibitors must supply their own ropes and stanchions; however, they are not required. Please remember your car is the feature and all other items in your display should be kept to a minimum. Your display must be within your space. Arrangements for electrical needs must be approved by Show Producers prior to entry deadline (3/1/16)

Move-In/Set-up: Begins Friday, March 23, 2018 from 8:00 am to 9:00 pm

All entries must be ready by Saturday, March 24 at 9:00 am

Displays may not be dismantled prior to show closing at 5:00 pm, March 25, 2018

All vehicles must be out by 8:59 pm or your vehicle will be towed at your expense.

Special arrangements must be made before the entry deadline

Disclaimer:

I agree to indemnify and hold harmless Northwest Rodarama Rod and Custom, LLC, its producers, sponsors, officers, directors, shareholders, or the owners of the building from which the show is produced from all claims of every nature and kind whatsoever in relation to the Northwest Rodarama Rod and Custom show occurring at the Washington State Fairgrounds in Puyallup, Washington. Any direction to the contrary should be attached to this form and signed. Exhibitor agrees to obtain insurance covering the above and assumes full responsibility of any loss or damage. Exhibitor agrees that this signed entry form supersedes any and all prior agreements and understandings whether written or oral between exhibitor and producers, show staff, representatives and sub-contractors. Nothing herein shall be modified unless agreed to by the producers in writing.

Each exhibitor Package includes two (2) Full Exhibitor Passes as well as promotional items provided by our sponsors. Parking is free. Each exhibitor will receive an Appreciation Award.

Proof of insurance must be provided.

Uniform Fire Code: Less than one-quarter (¼) tank of fuel or no entry into building. Gas cap taped off. Battery terminals disconnected and taped. No flammable materials or emergency flares in the displays. No Compressed Gas Cylinders of any type.

If exhibitor is below the age of 18, a legal guardian must sign.
